A customs declaration is an official document that gives details of goods that are being imported or exported into or out of EU customs territory. It is the legal act whereby an operator indicates their intention to place those goods under an EU customs procedure, as described in the Union customs. Prior to moving goods into the Union's customs territory an entry summary declaration (Summarische Eingangsanmeldung - ESumA) shall be lodged. You'll need to use the UK Trade Tariff to help complete your import or export declaration. Our terms of delivery are based on the International Commercial Terms (Incoterms).
